Resolved, that the Somerset Hills Board of Education reviewed the Harassment, Intimidation, and Bullying cases presented on April 29, 2015 and upheld the findings and/or consequences recommended by the Superintendent.

4. PARCC Resolution

Resolved, that the Somerset Hills Board of Education ("BOE") fully supports educational policies and practices designed to provide results that promote and improve student achievement, college and career readiness, lifelong learning and best teaching practices; and

WHEREAS, the New Jersey Board of Education has adopted the Partnership for Assessment of Readiness for College and Careers ("PARCC") tests developed by a consortium of states, as the exclusive and required form of State assessment for public school students in grades 3-11, administered for the first time this school year and if the Somerset Hills School District ("SHSD") refused to administer the PARCC test, it would likely result in a loss of State funding; and

WHEREAS, the BOE recognizes that a sound, well-vetted standardized assessment aligned appropriately to meaningful standards and administered in developmentally appropriate ways can inform our understanding of students, programs and instruction; and

WHEREAS, the BOE stands committed to the Common Core State Standards ("CCSS") but understands and shares administrators, teachers, parents and the public's concerns regarding CCSS testing through the use of the PARCC test and its impact on the BOE, including the loss of instructional time, the lack of timely feedback from the test to be used to assist instruction, the potential over testing of students, the ambiguity of a prescribed State penalty for refusal to take the test, the disruption to the school calendar and the use of scores to evaluate teacher performance, student placement and high school graduation; and

WHEREAS, the BOE believes in its ability to measure student achievement, evaluate staff performance and determine student readiness for graduation without the use of the PARCC assessment; and

WHEREAS, for the past several years, the SHSD has fully complied with the district's legal obligation to take all necessary and appropriate measures to ensure the district's readiness for the administration of the PARCC tests this year even though it interfered with and reduced administrative planning and preparation for other district program priorities, and to ensure students' readiness to take those assessments acknowledging that the actual testing time disrupted the school calendar resulting in reduced instructional time; and

WHEREAS, the implementation of the PARCC tests created organizational strains including budgetary impacts, technological constraints and required upgrades and reallocation of staff; and

WHEREAS, the PARCC assessments are an unfunded mandate with the financial costs of implementing the tests shouldered almost entirely by local school districts and local taxpayers; and

WHEREAS, the SHSD has spent approximately \$92,000 for technology enhancements, professional development and administrative and teaching staff time to implement this mandate; and

WHEREAS, the SHSD dedicated with great difficulty, significant technology resources, including professional support, to provide the means to test students in a computer based testing environment; and

WHEREAS, the approximate time spent in training, preparing, coordinating, attending meetings, administering, reporting and actual taking of PARCC assessments included 1550 hours for Test Coordinators who are SHSD Curriculum Supervisors and Assistant Principals, 365 hours for the Guidance teams, 258 hours for Administrators, 180 hours for the Technology team, 172 hours for the Child Study Team, 90 hours for Secretarial services, 35-45 hours per teacher for Teacher prep and 20-25 hours per student for Student tutorials/testing; and

WHEREAS, the BOE questions the reliability and validity of the data due to the high percentage of students refusing to sit for the assessment, particularly Bernards High School students 50% refusal, and the effect the data will have for teacher evaluations and external assessment of the school district; and

THEREFORE BE IT RESOLVED, that the BOE shall follow its established discipline and attendance policies but shall impose no disciplinary consequences on students whose parents refuse the test on behalf of their children; and

THEREFORE BE IT FURTHER RESOLVED that PARCC scores will not be a factor in student placement for the 2015-2016 school year; and

THEREFORE BE IT FURTHER RESOLVED that the BOE directs the administration to minimize the impact of PARCC test scores on teacher and administrative evaluations to the greatest extent allowed by law for the 2015-2016 school year; and

THEREFORE BE IT FURTHER RESOLVED that the BOE encourages the Governor, State Legislature, the Commissioner of Education, the State Board of Education and Study Commission on the Use of Student Assessments in New Jersey to reconsider the speed, timing, amount and financing of testing and consider exempting 11th graders who fulfill graduation requirements of competency in Language Arts or Math through the SAT or ACT.
